REGARDLESS.**

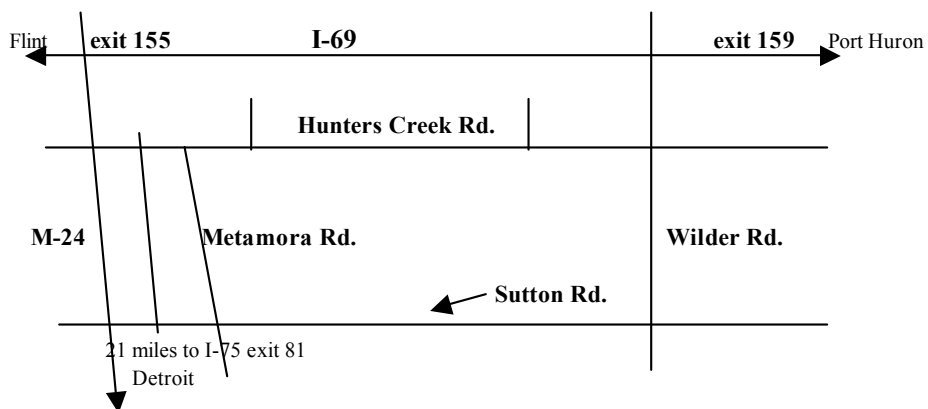
